LIPPO CIKARANG REPORTS REVENUE OF Rp1,844.7 BILLION IN FY21 AND MARKETING SALES OF Rp1,230.0 BILLION AS DEMAND FOR WATERFRONT ESTATES AND INDUSTRIAL LAND REMAINED STRONG

- FY21 Marketing Sales reached Rp1,230.0 billion, an increase of 21.2% YoY, led by industrial land sales and residential sales in Waterfront Estates.
- Revenue remained strong at Rp1,844.7 billion, supported by timely handovers of Waterfront Estates and Orange County, which comprised 72.3% of total revenue.
- FY21 EBITDA reached Rp465.7 billion, representing an increase by 5.6% from Rp441.0 billion in the year ago period.

Cikarang – PT Lippo Cikarang, Tbk ("LPCK") today announced financial results for the fullyear 2021. The Company reported total revenues of Rp1,844.7 billion, of which residential houses and apartments amounted to Rp1,334.6 billion, up 5% from Rp1,265.4 billion in FY20. Revenue from residential houses and apartment contributed 72.3% of the total revenue while industrial and commercial revenue accounted for 5.9% of the total.

As reported, gross profit for the period slightly decreased by 2.2% to Rp690.5 billion in FY21 from Rp706.0 billion in FY20. Residential houses and apartments which comprise 63.7% of total gross profit in FY21 increased by 4.3% to Rp439.7 billion. Gross Margin slightly decreased to 37.4% from 38.3% mainly due to product mix.

LPCK's total assets decreased by 6.0% to Rp9,134.5 billion at the end of 2021 from Rp9,719.5 billion in 2020. The cash balance as at FY21 was Rp376.2 billion down from Rp635.4 billion in FY20, due mainly to dividend distribution during the year.

Rudy Halim, CEO of PT Lippo Cikarang Tbk, said : "In 2021, the property industry faced tough challenges due to disruptions brought about by Covid-19. We are encouraged by the progress we have achieved in 2021 amidst this challenging environment and we look forward to continuing to deliver on our commitment to the needs of the East Jakarta Corridor community in 2022.
