Lippo Cikarang Topping Off Orange County Mall, Japanese Architecture with a Vertical Garden Concept in West Java

PT Lippo Cikarang Tbk has topped off the Orange County Mall today, which is located in the Central Business District of Orange County Lippo Cikarang, West Java. Orange County is a project of PT Lippo Cikarang Tbk with the concept of a globally connected city with 6 premium apartment towers, all of which have been topping off, and 5 of them have been handed over to customers since September 1, 2018.

Orange County Mall is a collaboration between Lippo Malls Indonesia, Kengo Kuma, and Mitsubishi Jisho Sekkei that will create a qualitative and aesthetic mall concept by carrying out a vertical garden concept.

President Director of PT Lippo Cikarang Tbk, Simon Subiyanto said: "Orange County Mall Phase I can operate from 2020 and is expected to become a new icon in the East Corridor of Jakarta, and can contribute a lot to the overall development of business and economy in Cikarang and Bekasi District."

The construction of Orange County Mall is the first phase covering 283,000m² with a height of 4 floor. On February 11, 2020, PT Lippo Cikarang Tbk had also signed a cooperation agreement with Savills Indonesia to bring prominent tenants to Orange County Mall.
