Some of the advantages of implementing the 'Eco Industrial Park', among others, are to encourage companies to face competition, the industry will dominate exports, encourage the industry to bring up new innovations and have a positive impact on cost efficiency.

Industry 'Best Practice'

Apart from the presentations from the three main speakers, the seminar also featured three industry representatives who have implemented EIP, including PT Schneider Electric Manufacturing, PT ABB Sakti Industri and PT Asahimas Chemical to share their experiences in implementing EIP in industrial operations.

Devina Satyapraba Raditya from PT Schneider Electric Manufacturing was one of those who presented industry 'best practices' in her company, saying that her party used digitalization to 'monitor' energy use and waste disposal. So that it can evaluate and also reduce excessive use of energy.

Exposure to these various 'best practice' experiences allows the industrial 'tenants' present to learn and apply various things to be able to support their company into the 'Eco Industrial Park'.
